The Singapore Taekwondo Federation (STF) 47th Annual General Meeting (AGM) proceeded at 7.32pm on 15 September 2024 with Mr. Lai Han Seng, the Secretary General, reporting a quorum of 67 Full Members out of 91 Full members and another 6 Associate Members out of 55 Associate Members present at the meeting. The minimum number of Full members required to form a quorum is 23 Full members, which was met. (Please see Annex I for Attendance List).

1. WELCOME MESSAGE FROM THE PRESIDENT OF SINGAPORE TAEKWONDO FEDERATION, PROFESSOR TAN CHENG HAN

Prof. Tan Cheng Han, thanked and welcomed all affiliates to the Singapore Taekwondo Federation (STF) 47th Annual General Meeting (AGM).

He mentioned that the welcome address is presented in the Annual Report and wished to highlight a few points in his address.

Prof. Tan Cheng Han emphasised that the STF Board has worked hard to enable the suspension to be lifted. He added that STF has continued to improve in the area of High Performance and Virtual Taekwondo and that STF's financial position remains healthy with surplus.

Prof. Tan Cheng Han expressed his deep appreciation to Board members Mr. David Koh, Mr. Sebastian Lee, Mr. Lai Han Seng, Mr. Johnny Lim, Mr. Lee Thiam Poh and Mr. Tan Cheng Hui, who will step down on the same day, In addition, the five Independent Board Members, Mr. Alan Chang, Mr. Koh Chin Beng, Mr. Laurence Goh, Ms. Monique Heah and Mr. Sinnathirai will also step

as well as Athletes Commission Chairman, Mr. Lawren Poh. While an Athletes Commission election will be held at a later date.

There will be six Board members to be elected at the 47th AGM and he thanked all the nominees who have stepped forward to serve. In conclusion, he invited the outgoing Board Members to continue to support STF in other ways and/or serve in the various committee and encourage all to come together for the good of Taekwondo.

6.1.2 The Secretary General Mr. Lai Han Seng declared the Resolution 1 was approved and confirmed.

6.2 Resolution 2: To receive and adopt the Audited Financial Statements and Auditor's Report for the Financial year ended on 31 March 2024

The Treasurer Mr. Johnny Lim reported on the Auditor's Report for the Financial year ended on 31 March 2024. He stated that in the auditor's opinion that the accompanying financial statements of the Federation are properly drawn up in accordance with the provisions of the Societies Act 1966 ("the Societies Act"), the Charities Act 1994 ("the Charities Act") and Charities Accounting Standards ("CAS") so as to give a true and fair view of the financial position of the Federation as at 31 March 2024 and of the financial performance, changes in funds and cash flows of the Federation for the year ended on that date.

He further stated that in the auditor's opinion, the accounting and other records required by the Act to be kept by the Federation have been properly kept in accordance with the provisions of the Act.

6.3.2 The Treasurer Mr. Johnny Lim declared the Resolution 3 was approved and confirmed.

To transact any other business brought forward in accordance with the STF Constitution, Clause 12.4

7.1 The Secretary General Mr. Lai Han Seng reported that there were no matters raised by any member as per clause 12.4.

8 To elect a total of six (6) Board Members according to the STF Constitution clause 16.2

- 8.1 The Secretary General Mr. Lai Han Seng announced that there are six (6) Board positions to be elected. There are five (5) Board Members who will be stepping down as four of them have served a maximum tenure of eight (8) consecutive years on the Board, one has completed the first four (4) year term and another Board Member due to resignation. Of the six (6) Elected Board Members, five (5) Board Members would be elected for a four-year term from 2024 to 2028 and one (1) Board Member with the lowest vote of the six would be elected for a two- year term of office from 2024 to 2026, to allow for staggered terms of office.
- 8.2 Mr. Lai Han Seng reaffirmed the delegates present have been authorised to vote. He announced that one delegate has been rejected due to different name registered.
- 8.3 Before voting began, an empty voting box was presented on the table in front of all voting members. The election was supervised by Ms. Monique Heah Cheng Siew. The two scrutineers were Mr. Mok Li Hao Thomas and Ms. Heng Xin Yi Cindy, the counting agents appointed were IBMs, namely Mr. Alan Chang Chi Hsung, Mr. Laurence Goh Eng Yau and Mr. S Sinnathurai. The nominees were also introduced to the voting members.
- 8.4 CEO Ms. Ang Lay Kwang then called the voting members individually and IBMs Mr. Laurence Goh Eng Yau and Ms. Monique Heah Cheng Siew affirmed the voting status of the members before distributing the voting slip to them. The voters casted their vote at the tables set up at the front and placed their voting slips in the voting box. A total of 67 voting slips were distributed.

9 Announcement of Voting Results

- 9.1 After all voters have voted. It was announced that the box would be opened for vote counting. IBM Mr. Laurence Goh Eng Yau and Ms. Monique Heah Cheng Siew counted all the voting slips, while the two scrutineers Mr. Thomas Mok and Ms. Cindy Heng verified the forms to ensure validity.
- 9.2 IBM Mr. Laurence Goh Eng Yau announced a total of 67 voting forms were collected, of which one was spoilt vote and 66 voting slips were accepted.
- 9.3 IBM Mr. Alan Chang Chi Hsung read out the vote and each vote was recorded real-time on excel file which was displayed on the TVs where voting members viewed. The two scrutineers Mr. Thomas Mok and Ms. Cindy Heng, IBMs Mr. Laurence Goh Eng Yau, Mr. S. Sinnathurai and Ms. Monique Heah Cheng Siew observed the counting of votes at close guarters.
- 9.4 Mr. Laurence Goh Eng Yau announced the results of the election and declared the first five nominees with the highest vote count are Mr. Lee Thiam Huat, Mr. Tan Gee Kee, Mr. Tok Yee Long, Mr. Lee Jie Yao and Mr. Ng Hwa Ann. There was a tied in vote between two nominees, Mr Kim Joon Yoon (Daniel) and Mr. Ng Kok Pheng at the 6th position with both obtaining 31 votes. Hence a re-vote was necessary to be conducted for them.

- 9.5 The voting process conducted was the same as the first round of voting. A total of 62 voting slips were collected, of which one was spoilt vote and 61 voting slips were accepted.
- 9.6 IBM Mr. Alan Chang Chi Hsung read out the vote and each vote was recorded real-time on excel file which was displayed on TVs and viewed by the voting members. The two scrutineers Mr. Thomas Mok and Ms. Cindy Heng and IBM Mr. Laurence Goh Eng Yau. Ms. Monique Heah Cheng Siew and Mr. S. Sinnathurai observed the vote counting at close quarters.
- 9.7 Mr. Laurence Goh Eng Yau Laurence announced the results of the revote with Mr. Kim Jong Yoon Daniel obtaining higher vote (32 votes) than Mr. Ng Kok Pheng (29 votes).
