3. WELCOME MESSAGE FROM THE PRESIDENT OF SINGAPORE TAEKWONDO FEDERATION, PROFESSOR TAN CHENG HAN

It is a distinct privilege to be with all of you today. We extend our sincere gratitude for your presence at the 48th Singapore Taekwondo Federation (STF) Annual General Meeting 2025. Your attendance, despite your busy schedules, is a powerful testament of your valued support, which is fundamental to the Federation's mission and future progress.

3.1 Our Achievements Together in FY2024/2025

3.1.1 National Programmes

The past year was a period of significant activity and purpose for the Singapore Taekwondo Federation, with numerous programmes and initiatives designed to benefit our affiliates, athletes, and the wider community. Our calendar was packed with events like quarterly centralised gradings and a variety of educational courses, from coach induction to certification for coaches and referees. These initiatives were crucial for developing a clear and supportive pathway for our athletes and technical officials to grow. The frequent gradings provided consistent benchmarks for our practitioners, while the educational courses empowered our coaches and referees with the latest knowledge and skills, ensuring a high standard of instruction and officiating across all levels of the sport. This focus on continuous development is key to nurturing the next generation of taekwondo talent.

We saw great participation in national tournaments, including the National Schools Games, the GetActive! Singapore Pesta Sukan Taekwondo 2025, and the Singapore Open Taekwondo Championships 2025. These events not only provided a platform for our athletes to compete at a high level but also fostered a strong sense of community and sportsmanship. A key highlight was our continued commitment to inclusivity; for the second consecutive year, we hosted the National Para Taekwondo Poomsae Competition and successfully integrated Para Taekwondo to the GetActive! Singapore Pesta Sukan Taekwondo 2025 and the National Poomsae Ambassador Championships 2025. This dedicated effort to create a more inclusive environment ensures that athletes of all abilities have the opportunity to participate and excel, reflecting our core belief that taekwondo is a sport for everyone.

3.1.2 International Foothold

On the international stage, last year was particularly momentous as Singapore hosted the inaugural Singapore 2024 World Taekwondo Virtual Championships on 16 and 17 November 2024 at the Singapore Sports Hub OCBC Arena Hall 1. The resounding success of this groundbreaking event, along with the previous OEW, demonstrates that Virtual Taekwondo has firmly established itself, not only within

Singapore but also on the global stage. This achievement highlights our commitment to embracing innovation and a forward-looking approach to the sport, ensuring its continued relevance in a digital world. The enthusiastic participation and positive reception from the global taekwondo community were a clear indication that this new format is here to stay, offering a new dimension to taekwondo competition and engagement worldwide. We are proud to have been at the forefront of this evolution, setting a new benchmark for virtual sporting events.

3.1.3 High Performance Achievements

The Federation has continued to soar new heights in high performance. Our national athletes achieved a strong standing with achievements in:

- a. WT President's Cup (Oceania) in Australia with 6 Gold medals
- b. 6th Asian Taekwondo Open with 2 Gold, 2 Silver and 4 Bronze in the Championships.

The total medal haul achieved by our national team in FY24-25 I International tournaments was remarkable, with an overall achievement of 14 Gold, 6 Silver and 10 Bronze medals. I am certain our athletes will put on their very best performance for the upcoming 2025 South-east Asian (SEA) Games happening in Bangkok, Thailand later this year.

Let us not forget our athletes who made their extremely strong debut in the 2024 Singapore World Virtual Taekwondo Championships, with a total medal tally of 4 Gold, 4 Silver and 1 Bronze medal in the 5 categories.

These remarkable results could only have been achieved the collective effort and sacrifices made by every member of our Taekwondo community. From athletes and their family, spectators, coaches, technical officials, to volunteers, committee chairpersons and sponsors; everyone has played a part in contributing to our stellar performance we have achieved in the past year and we count on their continued support to build an even brighter future for our sport.

3.2 Bedok National Training Centre (NTC)

Last year, the STF's office and training centre for the Kyorugi Team moved to Bedok North with improved facilities and proximity to Bedok Sports Hall and Bedok Stadium. The move was part of SportSG's initiative to include STF/Taekwondo as part of their Singapore Combat Sports Centre (SCSC) whereby combat/pugilistic sports are grouped within a centralised training facility to develop and harness synergistic benefits between such sports that come with shared use of facilities such as a state-of-the-art fitness gymnasium. The SCSC also provides additional funding that focuses on preparation for Major Games campaigns to give the sports under

SCSC the best chance to achieve podium success.

We are proud that STF has been chosen as the lead tenant to run SCSC, considering our track record of good governance and leadership in recent years. We hope to take full advantage of the Bedok National Training Centre by:

- a. enabling our Virtual Taekwondo National Development Squad to train alongside the Kyorugi team,
- b. conducting smaller scale competitions, courses and gradings.

3.3 New Team Same Direction

In the last STF Annual General Meeting in 2024, STF saw the transition of six board members stepping off the Board as most of them had reached their term limit. The Board Members were Mr. David Koh, Mr. Sebastian Lee, Mr. Lai Han Seng, Mr. Johnny Lim, Mr. Andy Lee Thiam Poh and Mr. Alvin Tan Cheng Hui. Their contributions have been monumental, and their unwavering dedication and commitment were instrumental to the development of Taekwondo in Singapore.

In the same STF AGM 2024, we also welcomed six new Board Members, i.e. Mr. Darran Lee, Mr. Tok Yee Long, Mr. Ng Hwa Ann, Mr. Tan Gee Kee, Mr. Alan Lee and Mr. Daniel Kim. The new STF Board will continue to actively engage with its stakeholders and provide steady and bold stewardship to meet the challenges of the future.

Volunteers within the various committees and sub-committees have continued to selflessly contribute their time and effort for STF. These acts of generosity and selflessness continue to cement STF's accomplishments, which are built on the solid foundation laid by our pioneers, including our late President, Mr. Milan Kwee, and our former General Manager, Mr. Lim Tiong Chin. The unwavering commitment and visionary leadership of our pioneers have been instrumental in paving the way for the growth and development of Taekwondo in Singapore.

In closing, the Board extends its profound gratitude for your strong cooperation and unwavering support throughout the past year. 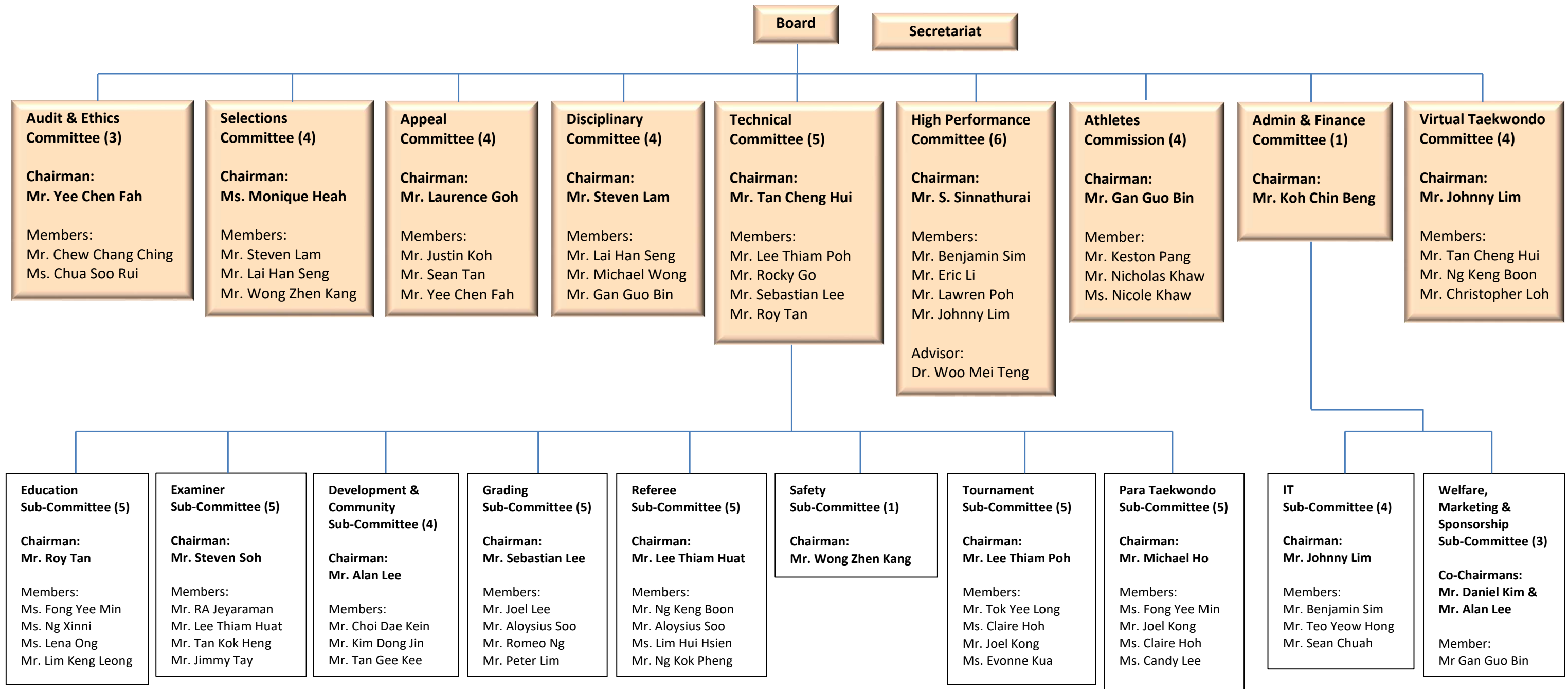

5. HIGHLIGHTS OF THE YEAR

5.1 Financial Reserve Policy

The charity has a reserve policy for long-term stability of the operations and it ensures that there are sufficient resources to support the charity in the event of unforeseen circumstances. As a general rule of thumb, the charity targets to maintain free reserves in unrestricted funds at a level which equates to more than one year of operational expenditure kept as reserves. The reserve level is reviewed yearly by the Board to ensure that the reserves are adequate to fulfil the charity's continuing obligations.

The financial reserves are to provide financial stability and the means for the development of the Federation's numerous activities. The STF financial reserves position are as follows:

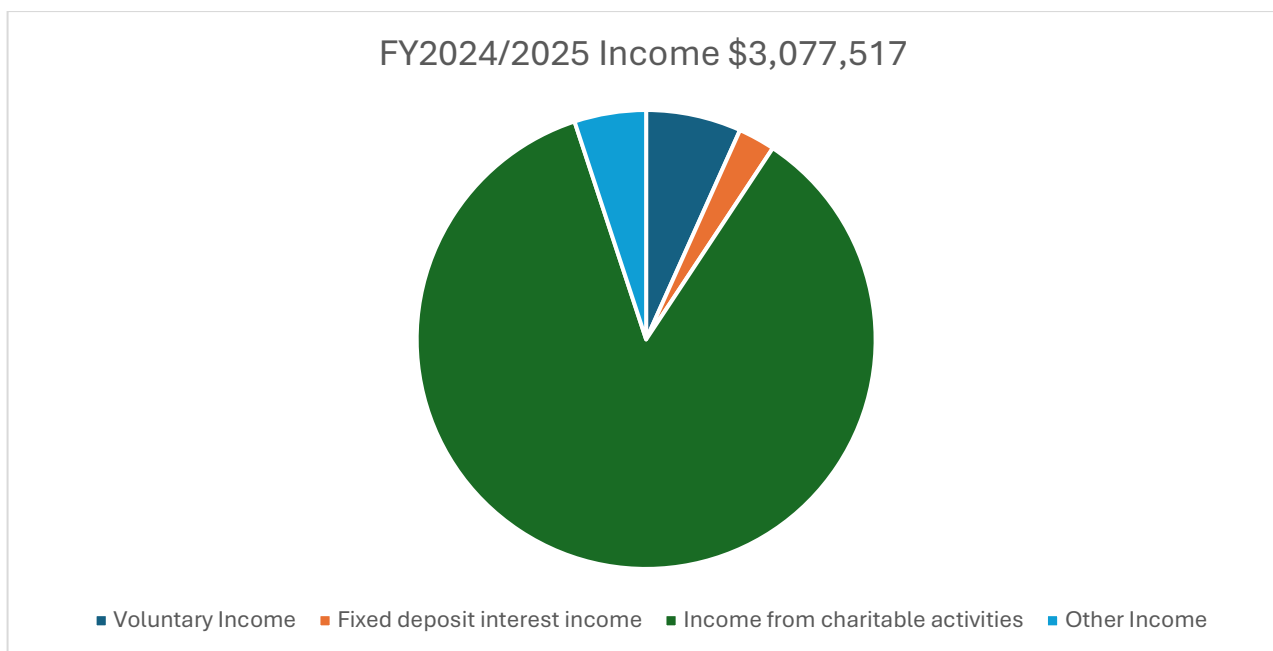

5.3 Summary of Financial Performance for the Financial Year ended 31 March 2025

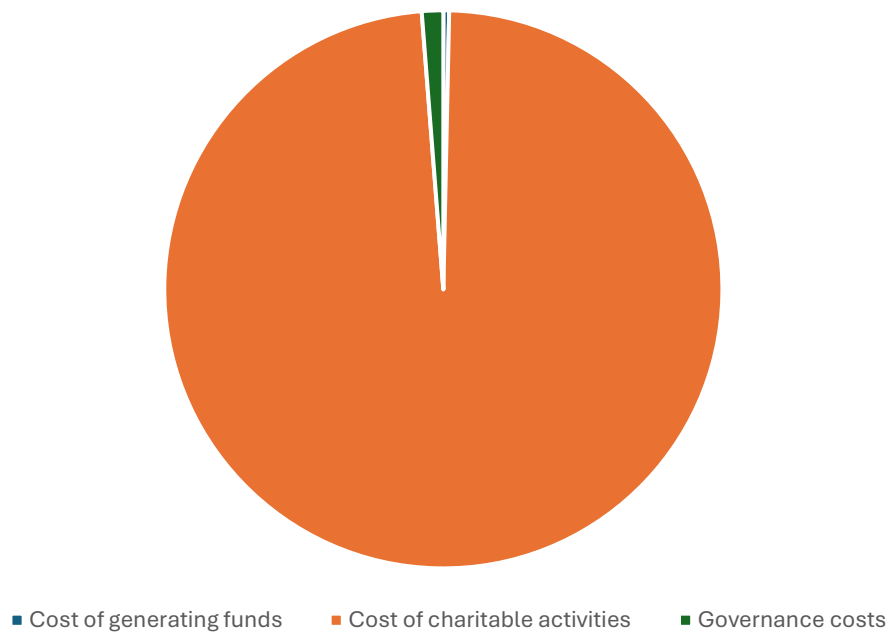
There has been an increase of \$1,322,025 in this year's income when compared with last year. The increase of income was mainly contributed from the grants and donation received for Singapore 2024 World Virtual Taekwondo Championships, grants received for Singapore Combat Sports Centre and higher participation in various STF tournaments.

In terms of expenditure, there has been an increase of \$2,007,036 compared to last year due to more events including Singapore 2024 World Virtual Taekwondo Championships, courses and seminars being held by the Federation and incurrence of expenditure for Singapore Combat Sports Centre during the financial year.

There has been a deficit of \$426,883 for the year. The accumulated funds are reported at \$6,643,001.



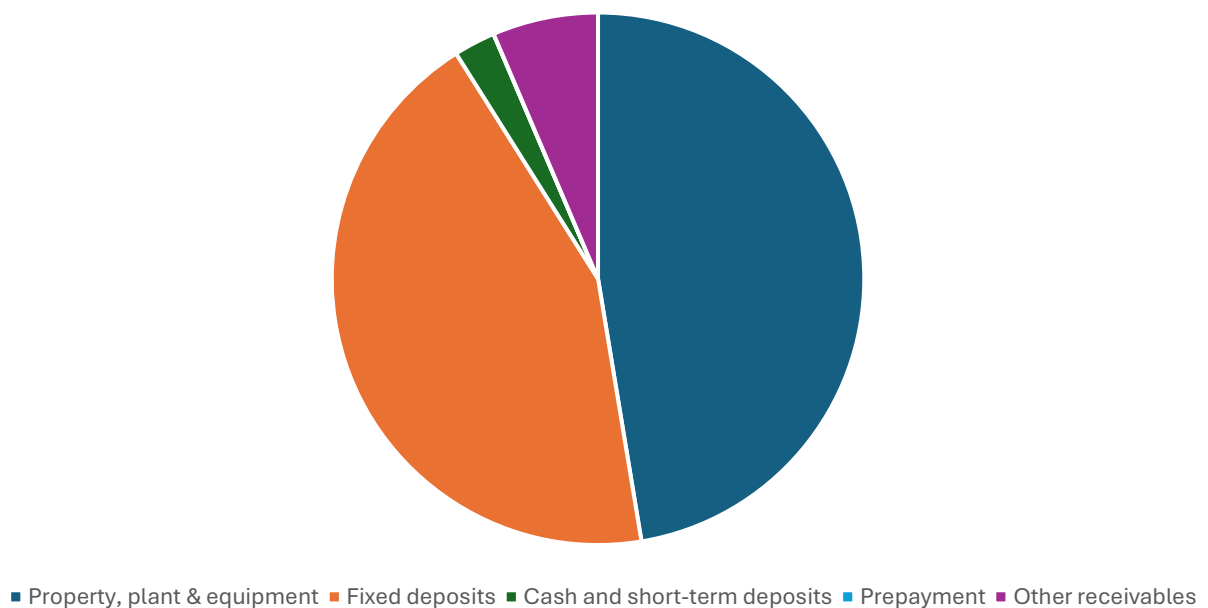
FY2024/2025 Expenditure \$3,504,400

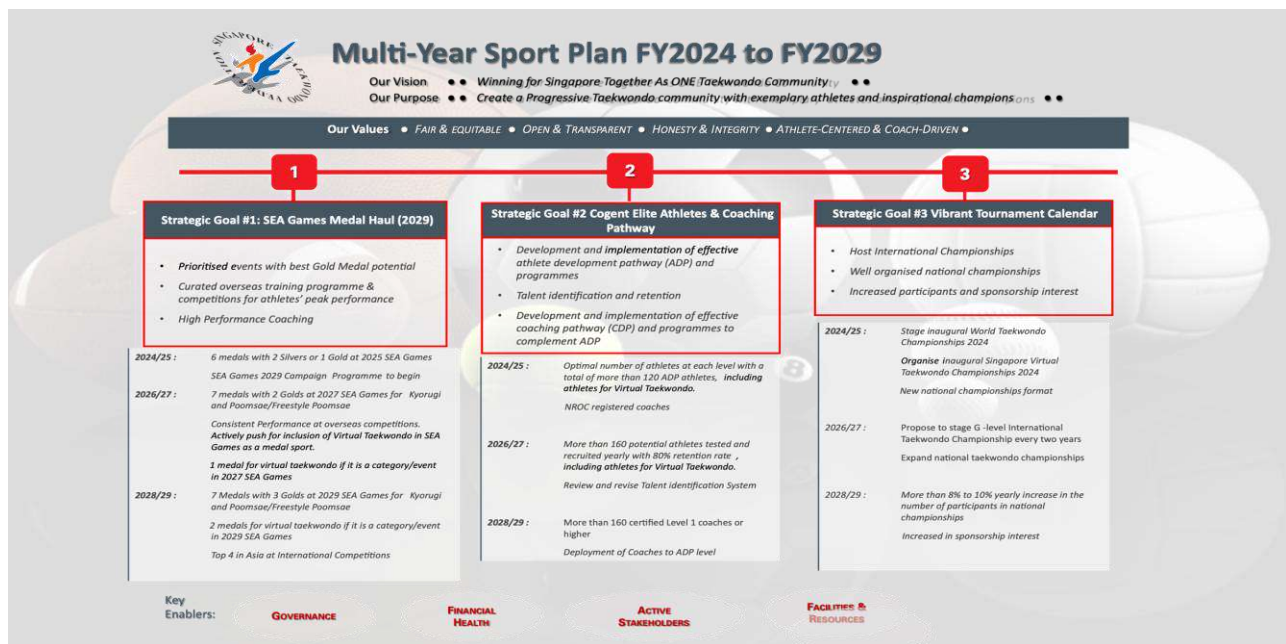

8. GOVERNANCE

8.1 Conflict of Interest

8.1.1 IPC – Conflict of Interest Policy

All Board members and staff are required to comply with STF's conflict of interest policy. The Board has put in place procedures to declare actual or potential conflicts of interests on a regular and need-to basis. Board members also abstain and do not participate in decision- making on matters where they have a conflict of interest.

The following "Conflict of Interest" policy is practiced by the Board.

"Board members are expected to avoid actual and perceived conflicts of interest. Where Board members have personal interest in business transactions or contracts that the Federation may enter into or have vested interest in other organizations that the Federation have dealings with, they are expected to declare such interests to the Board as soon as possible and abstain from discussion and decision making on the matter. Where such conflicts exist, the Board will evaluate whether any potential conflicts of interest will affect the continuing independence of the Board member and whether it is appropriate for the Board member to continue to remain in the Board."

All members have declared, as best as they know and believe, that under no circumstances are they are aware of what may be construed as a direct or indirect conflict of interest.

8.2 Term Limit of Board

The Elected Board members shall serve 4 years. However, for the 1st year of the new constitutional change, 5 Elected Board Members will serve a 4-year term and 4 with the lowest votes will serve a 2-year term. The Independent Board Members shall serve 2 years.

Board Members may serve a maximum of 8 consecutive years (from 2017), after which, shall only be eligible for re-election after a 2-year lapse. The Treasurer can only serve 4 years and may only be considered for re-appointment as a Treasurer after a lapse of at least 2 years.

The 4-year term was discussed and passed as a resolution to be included in the Constitution during the STF Extra-Ordinary General Meeting held on 11 June 2022 and subsequently, also approved by the Registry of Societies (ROS). This is to provide Board members with a longer runway to translate and operationalize strategic plans.

STF ventured into Virtual Taekwondo last year with the hosting of the Inaugural World Virtual Taekwondo Championships in Singapore. Together with the organising and working committee of the 2024 Singapore World Virtual Taekwondo Championships, as well as volunteers who volunteered their time, this inaugural World Championship in Singapore would not have been possible without you. Our national team has continued to perform well in regional competitions, ranging from WT President's Cup (Oceania) – Australia, to the 6th Asian Taekwondo Open Championships. The total medal haul of 14 Golds, 6 Silvers and 10 Bronzes in this FY is remarkable and this is only possible because of the dedication of the High Performance committee, the National Coaches and our national athletes for continuing to give their best and flying the Singapore flag high.
