19.2	Board members shall not be Individuals who are disqualified from serving on the Board of charities or companies pursuant to the Charities Act and Companies Act or have past convictions for offences for which criminal record cannot be spent pursuant to the Registration of Criminals Act (Third Schedule).	
19.3	Board members shall not be serving a suspension or ban from WT or other regulatory authority.
